1) Reported SB 1018 (S-1) with recommendation and immediate effect.

The Chairman called the meeting to order at 9:41 a.m. He instructed the Clerk to call the roll. At that time, the following members were present; Chairman Jansen, Sen.(s) Colbeck, Robertson, and Young, a quorum.

The Chairman invited Sen. Hildenbrand to summarize SB 1018 for the committee.

The Chairman invited Nick Ciaramitaro of AFSCME to testify in opposition to SB 1018.
