COMMITTEE MEETING MINUTES February 13, 2014

A meeting of the Senate Committee on Regulatory Reform was scheduled for Thursday, February 13, 2014, at 1:00 p.m., in Room 210 of the Farnum Building.

The agenda summary is as follows:

- 1) Reported SB 667 (S-2) with recommendation and immediate effect.
- 2) Reported SB 668 (S-4) with recommendation and immediate effect.

The Chairman called the meeting to order at 1:00 p.m. He instructed the Clerk to call the roll. The following members were present; Chairman Rocca, Sen.(s) Jones, Hune, Meekhof, Pavlov, Johnson and Warren, a quorum.
