COMMITTEE MEETING MINUTES

May 22, 2014

A meeting of the Senate Committee on Regulatory Reform was scheduled for Thursday, May 22, 2014, at 11:00 a.m., in room 210 of the Farnum Building.

The agenda summary is as follows:

- 1) Reported SB 947 (S-1) with recommendation and immediate effect.
- 2) Reported HB 4582 (S-1) with recommendation and immediate effect.
- 3) Reported HB 5284 with recommendation and immediate effect.

The Chairman called the meeting to order at 11:00 a.m. He instructed the Clerk to call the roll. The following members were present; Chairman Rocca, Sen.(s) Jones, Hune and Meekhof, a quorum.

The Chairman entertained a motion from Sen. Hune to adopt the minutes of the May 15, 2014, committee meeting. Without objection, the minutes were adopted.

The Chairman invited Sen. Jones to summarize SB 947 and the (S-1) for the committee.
