**June 17, 2015**

A meeting of the Senate Committee on Appropriations was scheduled for Wednesday, June 17, 2015, at 2:00 p.m., in the Senate Appropriations Room of the Capitol Building.

The agenda summary is as follows:

The Chairman called the meeting to order at 2:05 p.m. He instructed the Clerk to call the roll. At that time, the following members were present; Chairman Hildenbrand, Sen.(s) MacGregor, Proos, Booher, Schuitmaker, Green, Hansen, Nofs, Marleau, Stamas, Shirkey, Knollenberg, Gregory, Hopgood, Hertel, Knezek, a quorum was present.

The Chairman entertained a motion from Sen. Proos, supported by Sen. Shirkey, to excuse absent members from the committee meeting. Without objection, Sen. Young was excused.

The Chairman entertained a motion from Sen. Schuitmaker, supported by Sen. Booher, to adopt the committee meeting minutes from the June 10, 2015 meeting. Without objection, the minutes were adopted.

The Chairman invited Sen. Horn and his Legislative Director Melanie Ellison, to summarize SB 356.

Next, the Chairman invited Ellen Jefferies of the Senate Fiscal Agency to summarize the Legislative Transfer Request 2015-4.

The Chairman entertained a motion by Sen. Hansen, supported by Sen. MacGregor, to adopt the Legislative Transfer Request 2015-4. The vote was as follows:
