Dear Mr. Haskins:

Thank you for your letter seeking assistance from the Department. Our records do not show the referenced company licensed. Therefore, we will not be actively pursuing a complaint in this matter. However, we will send the party you named a letter informing them of the need to be licensed to perform regulated activities.

We do not pursue complaints against unlicensed parties because the administrative penalties which we may assess in these cases cannot be readily enforced. We, therefore, encourage parties to pursue complaints against unlicensed parties with the local county prosecutor. The prosecutor can prosecute these cases as misdemeanors, with a maximum penalty of \$500 fine and/or 90 days in jail. Our enforcement agents will provide assistance in preparing cases if requested.

Thank you for bringing this matter to our attention. However, we will be taking no further action on this complaint.

Dear Respondent:

It has been noted during a review of the above matter by the Department of Consumer & Industry Services that your office located at Chicago, Illinois is not licensed at the address provided above. A copy of the advertisement submitted is attached. You may be in violation of Sections 904(1) and/or 601(1) of 1980 PA 299, which state as follows:

“A person shall not engage in or attempt to engage in the practice of an occupation regulated under this act or use a title designated in this act unless the person possesses a license or certification of registration issued by the Department for this occupation.

“A person shall not operate a collection agency or engage or commence in the business of a collection agency without first applying for and obtaining a license from the department for each place of business.”

However, Section 904(2) of 1980 PA 299, effective April 1, 1995, states:

“A person is not subject to the licensing requirements of subsection (1) if the person’s collection activities in the state are limited to interstate communications. This subsection does not exempt a person from other requirements of law that regulate collection practices.”

Unlicensed violations are considered serious by the Department. Continuation of this practice could result in a fine of up to \$10,000.00 for each violation, or criminal prosecution. Referral of this matter may be made to the local prosecutor or police department.

If you intend to continue to perform activities that require a collection agency license, you must obtain a license immediately. Please call (517) 241-9246 to obtain information on how to become licensed.

IMPORTANT NOTICE TO FINANCIAL INSTITUTIONS

TO: Consumer Credit Officers

DATE: September 26, 1995

It has been brought to the attention of the Collection Practices Boards that there are a number of repossessioners working in the state without being licensed as required by PA 299 of 1980, the Occupational Code. Under the Code, **anyone who repossesses on behalf of another entity is required to be a licensed collection agency.**

Members of the collection industry believe that financial institutions of all types can help reduce the number of unlicensed repossessioners, by only hiring those who are properly licensed to repossess on the institution's behalf. We suggest that when hiring a repossessioner your staffs ask for proof of the repossessioner's current license, or call 1-900-555-8374 to verify the agency's license with the Bureau of Occupational and Professional Regulation.

Please note that licensure is only required of those working for others; employees of financial institutions who are repossessing for the institution (or employees of other businesses working on behalf of their employers) do not need to be licensed.

While we realize that it is impossible to eliminate all unlicensed repossession activity, we believe that the assistance given by financial institutions will help to curtail this problem. Your cooperation in sharing this information with your staff is greatly appreciated. If you have any questions or comments please feel free to contact me.
