These amounts are shown at the initial appropriation. Year-end transfers moved undistributed funds from statutory formula-based appropriations to grant programs. The amount of these transfers was \$252,300 in FY 2011-12, \$239,400 in FY 2012-13, \$100,300 in FY 2013-14, \$184,400 in FY 2014-15, \$88,061 in FY 2015-16, \$282,918 in FY 2016-17, \$219,410 in FY 2017-18, \$140,371 in FY 2018-19, and \$202,942 in FY 2019-20.
