RE: August 2020 Consensus Revenue Estimating Conference

A Consensus Revenue Estimating Conference has been announced for Monday, August 24, 2020, convening at 3:00 PM. This Conference is held pursuant to Public Act 72 of 1991, which requires the Director of the Senate Fiscal Agency, Director of the House Fiscal Agency, and either the State Budget Director or the State Treasurer to hold at least two revenue estimating conferences each year, in January and May. Additional conferences may be convened upon the request of a principal, as is the case for this August Conference.

Executive Order 2020-160, Section 1, reaffirms that any work capable of being performed remotely must be performed remotely. As was the case in May, the principals of the Consensus Revenue Estimating Conference have determined that the Conference will again be held remotely and broadcast live via the internet for the public to observe in accordance with governing statute. All sessions of the conference will be accessible to the public. The meeting proceedings will be broadcast by both the Michigan Senate and House TV internet feeds at the following sites:

Individuals without internet access can view a broadcast of the Conference proceedings from Room 403 of the State Capitol Building in Lansing. This location will be subject to appropriate social distancing protocols.

The Consensus Revenue Estimates also will be made available to the public on the Senate and House Fiscal Agency websites when a consensus is reached.
